For the 2020-21 rankings and ratings, U.S. News evaluated more than 4,500 medical centers nationwide in 16 specialties, 10 procedures and conditions. In the 16 specialty areas, 134 hospitals were ranked in at least one specialty. In rankings by state and metro area, U.S. News recognized best regional hospitals based on high performing rankings across multiple areas of care.

### **MHN Begins Administering COVID-19 Vaccines**

On Friday, Dec. 11, the Food and Drug Administration issued an emergency use authorization for a COVID-19 vaccine developed by Pfizer and BioNTech. The State of West Virginia has developed a CDC/ACIP approved state-wide COVID-19 Vaccination Plan. WV Governor Justice further categorized 1-A priorities for healthcare workers beginning with those at greatest risk working in ER/ICU/COVID units. The WV Vaccination Plan outlines the process for distribution and administration in three phases, based upon vaccine availability and public health priorities.

MHN is obligated to follow the WV COVID-19 Vaccination Plan and the Governor's 1-A priorities. Both Cabell Huntington Hospital and St. Mary's Medical Center will receive weekly allotments of vaccine. Initial supplies of the two-dose vaccine are extremely limited and will first be allocated to employees who are at greatest risk of becoming infected from contact with COVID+ patients.

To prepare for future phases, managers have collected department lists of employees who wish to receive the vaccine. All employees who have expressed an interest in being vaccinated will be entered into the Vaccine Administration Management System (VAMS) employee portal when supply of vaccine is available for their risk group. VAMS is a secure, webbased tool built to support operations, data collection, and tracking to meet COVID-19 vaccination requirements.

If you expressed interest in receiving the vaccine, you will receive an email from VAMS when you have been selected for immunization. This email will provide a link for scheduling a vaccine clinic appointment. You must register and schedule within VAMS immediately to ensure that you receive the vaccine within the allotted time period, as there is a

limited time for all available doses to be administered. More specific instructions will be provided once you are selected.

All employees who wish to be vaccinated will be offered the opportunity at some point, but it is unknown how long it will take for supply to meet demand. WV DHHR has posted a COVID-19 Vaccine Frequently Asked Questions document to inform providers and the public in anticipation of activating the WV Plan. 
Increases Access to Quality Care for Humana Medicare Advantage Members


As the accrediting agency for Children's Advocacy Centers (CAC) across the country, National Children's Alliance awards various levels of accreditation and membership to centers responding to allegations of child abuse in ways that are effective and efficient, and put the needs of child victims of abuse first. Accreditation is the highest level of membership with National Children's Alliance and denotes excellence in service provision.



"The CAC was developed at HFCH in 2017 to provide children and families with compassionate care to reduce the trauma often experienced by children who are

victims of abuse," said Marie Frazier, MD, medical director for the Pediatric Intensive Care Unit and the CAC. She is also an associate professor at the Joan C. Edwards School of Medicine in the Department of Pediatrics. "We are honored to be an accredited member of the National Children's Alliance."

National Children's Alliance awards accredited membership based on a CAC's compliance with 10 national standards of accreditation to ensure effective, efficient and consistent delivery of services to child abuse victims. National Children's Alliance updated these standards in 2017 to reflect the most recent evidence-based practices in the field of child abuse intervention and prevention. According to these standards, accredited members must utilize a functioning and effective multidisciplinary team approach to work collaboratively in child abuse investigation, prosecution,



and treatment. National Children's Alliance also considers standards regarding a center's cultural competency and diversity, forensic interviews, victim support and advocacy, medical evaluation, therapeutic intervention, and child focused setting.



"As a team of individuals dedicated to responding to child abuse, we recognize the importance of accreditation from National Children's Alliance and supporting the

multidisciplinary team approach," said Melanie Akers, director of the Hoops Family Children's Hospital.
